CFA Institute University Affiliation Program

In May 2011, ANU was awarded partnership status with CFA Institute for the Bachelor of Finance program. In January 2013, the partnership has been further extended to include the Master of Finance program. This recognizes that the degree programs will cover at least 70 percent of the CFA Program Candidate Body of Knowledge including the CFA Institute ethical and professional standards. The partnership program has been revamped in 2017 as the new University Affiliation Program.

Recognition as a CFA Institute Affiliated University signals that the degree's curriculum is closely tied to professional practices and is well suited to students preparing for the CFA exams. In addition, The CFA Institute University Affiliation program offers unique benefits to ANU students including resources exclusively available to affiliated universities and access to professional development opportunities provided in conjunction with CFA Society of Sydney and other key industry bodies.

About the CFA Program

The CFA Program sets a standard for developing the skills, standards, competence, and integrity of financial analysts, portfolio managers, investment advisers, and other investment professionals worldwide. To become a CFA charter holder, you must complete three exams in addition to other professional requirements. Each exam requires extensive hours of preparation and study materials are provided by CFA as part of the examination fee. As part of the CFA Institute University Affiliation Program, CFA Institute offers six student scholarships that cover part of the exam fee every academic year to ANU students.

CFA Institute University Affiliation Program Student Scholarships

Eligibility

Applicants must be enrolled ANU students at the time of application regardless of their enrolled program.

The Scholarship

The program awards six scholarships to successful applicants for any level of exam they intend to register. The scholarships waive the one-time program enrollment fee and reduce the exam registration fee to US\$600 under the Premium Registration Package which includes Practice Pack. Student scholarships are valid for one of four exam cycles, depending on the exam level, starting from the date a scholarship is awarded. Details will be provided in the award email from the Scholarship Team at CFA Institute. The unused scholarship will be forfeited in full by CFAI. If you fail to utilize your scholarship by not registering, not scheduling or not appearing for the exam, you will not be eligible to receive future scholarships. The scholarship may not be transferred to another student nor to another exam cycle.

The unsuccessful applicants for the scholarship will be able to register for an exam at the early registration price if the registration window is open and the early registration window has passed. Details will be provided in the scholarship decision email from the Scholarship Team at CFA Institute.

Students who have registered for an exam are not eligible to apply for or receive the student scholarship.

It is the student's responsibility to act upon the deadlines of exam registrations and/or to redeem benefits mentioned above.

Application

The application for the 2026-2027 academic year student scholarship will close **9th October 2026 (CFA Institute system time)**. Award decisions will be made by 23rd

October 2026. Application can only be made in the applicant's CFAI account. After filling in the application form online, the applicant must upload the **official ANU transcript** with the application. The application is only complete when all required information is filled in and the official ANU transcript is attached. Incomplete applications, late application and late submission of transcript will not be considered for the scholarship.

All applications and scholarship award decision are through the CFAI scholarship platform. We are not able to process any applications in other means such as email submissions. No transcripts from other universities or institutions are acceptable. A screenshot of the academic results or the downloaded academic results from the student administration system is not acceptable as "official ANU transcript". Please consult the school or college admin staff for the procedure of obtaining an official ANU transcript.

All six student scholarships will be allocated in one round in October 2026. If you put in your application after the closing date (the scholarship platform is open throughout September 2026 to July 2027), you will receive an email stating "not selected for award" and you are still eligible to receive the benefit of registering for an exam within the current exam cycle at early registration rate. All application record will be cleared from the scholarship platform after 31st July every academic year. You will be able to apply for the new round of scholarship from 1st September. There's no restriction of how many times you can apply for the scholarship. However, if you fail to utilize your scholarship by not registering, not scheduling or not appearing for the exam, you will not be eligible to receive future scholarships.

Selection Process

All eligible applicants will be ranked by the weighted GPA of all finance courses on their official transcript. A minimum of four finance courses (course code starting with FINM) are required to calculate a weighted average GPA for the purpose of the scholarship selection. The selection of successful recipients of scholarship is purely based on the academic merits as measured by the weighted average GPA of all finance courses that the students have completed at ANU. Transferred credits from other institutions and the grades of exempted courses as a result of previous studies at other institutions are not considered, therefore not included in the calculation of GPA for the scholarship purpose.

The scholarship decision will be made via the scholarship platform. When the "award" or "not award" decision is made, applicants will receive email notification immediately.
